

India Tourist Re-Entry Permit



INDIA RE-ENTRY PERMIT

Only applies to Tourist Visa Holders who want to re-enter India within 2 months of last exiting India.

Exceptions will be granted on a case by case basis (Reasons may include sick family members in India). To apply for an exemption please send the following:

1. Valid and signed U.S. Passport. Your passport must have a minimum of 6 months validity from expiration date. Must contain at least 2 blank pages.
2. One (1) visa application form. Application has two (2) pages. All questions answered and application signed. Important: Application must be completed online at <https://www.indian-visa.com/expedite/application/form>
3. **Re-entry Permission Form**: The form will automatically generate as a part of the application process. After printing, answer the questions not covered by the online application form. Please sign the form. A fillable form here: http://www.vp2go.com/pdfs/visa/Permit_Form.pdf
4. **Permit Support Letter**: A letter needs to: 1) State the urgency and purpose of the visit 2) State explicitly that the traveler will not engage in Business/Work related activities. Example Letter available here: http://www.vp2go.com/pdfs/visa/Permit_Letter.pdf
5. Two (2) passport quality photos. Must be 2" x 2" and in color.
6. Copy of your airline ticket, travel agent itinerary or e-ticket confirmation.
7. Photocopy of your driver's license as proof of residence in the Embassy's area of jurisdiction.

This permit will be granted only under exceptional circumstances. If a permit is granted, registration is required within 14 days of entry.
